#### New High Level Structure (HLS)

Brings a common framework to all management systems. This helps to keep consistency, align different management system standards, and apply common language across all standards.

#### Communication and Awareness

People working under an organization's control should be aware of the policy, objectives, implications of non-conformities etc. The communication plan can include a variety of mediums including briefings, meetings, seminars, conferences and newsletters.

#### **Risks & Opportunities**

Risk replaces preventive action. The organization should plan actions to address these risks and opportunities, how to integrate and implement the actions into its management system processes and evaluate the effectiveness of these actions.





#### Objectives should include plans on how to achieve them

as well as how the results will be evaluated. The organization must determine who will be responsible for the delivery of the objectives, resources required, what needs to be done and by when.


