Speakers' Profiles:



Mr. Philip Yang – Maritime & Commercial Arbitrator. Honorary Chairman of Hong Kong International Arbitration Centre, Past President of Asia Pacific Regional Arbitration Group, Chartered Fellow of the Chartered Institute of Logistics and Transport. Chartered Arbitrator.



Prof. Albert Leung – is a Chartered Engineer with over 35 years' experience in civil and structural engineering works. He is currently the Director of Operations at Jacobs China Limited. He has been involved in litigation, arbitration and expert witness works on various engineering projects. Currently he is an adjunct professor at HKU and City University for their Master Courses on arbitration law and practice. He is also an adjunct lecturer at the HKU SPACE postgraduate diploma in construction law and arbitration and the postgraduate diploma in construction law, mediation and arbitration courses. He is also the secretary for the Hong Kong Institution of Engineers Alternative Dispute Resolution Committee and represents the Institution on the HKIAC Appointment Advisory Board and the HKMAAL Mediation Accreditation Committee.



Prof. Anselmo Reyes – Anselmo practiced as a barrister in Hong Kong from July 1989. He was appointed Senior Counsel in May 2001. As a counsel, he had a broad experience in civil practice, specialising in shipping, commercial, company, revenue and telecommunication law cases. He became a judge of the Court of First Instance in 2003. As a judge, he heard numerous applications relating to arbitration. Anselmo stepped down from the Hong Kong Judiciary in September 2012 to practice as a commercial arbitrator and advocate in arbitrations. On 1 October 2012, Anselmo became Professor of Legal Practice at the University of Hong Kong. He is the author of two privately printed books: *Reflections on Civil Procedure under Civil Justice Reform* and *How To Be an Arbitrator: A Personal View*. The books are based on lecture series which he delivered in 2009 and 2012 respectively under the sponsorship of the HKMLA and the HKU Faculty of Law.



Mr. Ernest Yang - is a partner of and the Head of Litigation and Regulatory at DLA Piper's Hong Kong office. Ernest's main area of practice is commercial litigation and arbitration. He is experienced in handling international disputes covering areas such as sale of goods / trade and commodities, joint ventures, ship construction and offshore projects. Ernest has experience handling arbitration disputes in a variety of venues including Hong Kong, London, Singapore and the PRC, before institutions such as the HKIAC, LMAA, ICC, LCIA, SIAC and the BAC. Ernest writes and speaks regularly in Hong Kong and the PRC. He is the author of *Injunctions* published by China University of Political Science and Law; *Sale of Goods* published by the Law Press, China; and has co-authored texts on *International Arbitration* and *Evidence* published by the Law Press in China. Ernest has contributed to leading English texts including *Arbitration in Hong Kong: A Practical Guide*. Ernest has written for publications such as the *Journal of Business Law* and *Hong Kong Lawyer*, and is a guest tutor for the Hong Kong University LLM course on Arbitration Practice. Ernest was appointed a member of the Chinese People's Political Consultative Conference (CPPCC) in Shanghai in 2013, with a mandate to help Shanghai develop into an international arbitration centre. Chambers Asia Pacific 2013 has commended Ernest's arbitration expertise, quoting clients as saying: "*He is a blessing for us on the negotiation table.*"





Mr. Danny Mok - graduated from the Hong Kong Polytechnic (now the Hong Kong Polytechnic University) in 1991, studied shipping studies in the Nautical Department. He worked for a subsidiary of a listed international shipping company for more than 20 years and was responsible for handling all legal and claim matters. He was the director of the legal department before he decided to leave the company in 2014 in order to pursue his interest in arbitration. He has been arbitrating since 2001 and went full time in 2014. He has experience arbitrating in Hong Kong, London, Singapore and New York on ad-hoc and institutional basis. He is a panel member of the Hong Kong International Arbitration Centre, a member of the Hong Kong Maritime Arbitration Group, a supporting member of the London Maritime Arbitrators Association and a member of the Baltic Exchange. He is a fellowship of the Institute of Chartered Shipbrokers, a Member of the Chartered Institute of Arbitrators and an Associate Member of the Chartered Insurance Institute. He is the co-author of the Chinese book "Arbitration Law – from the Arbitration Act 1996 to international commercial arbitration" published by the Law Press in China.
