The abstract should be written in 11 points, Times New Roman and placed before the first section with a horizontal line before and after. All text, tables, formulae, etc., presented in this paper are formatted according to the instructions below:

**Keywords:** PRA, Nano Structures, Dynamic PSA, list no more than 4 keyword phrases.

## 1. INTRODUCTION

Authors should submit their full paper in MS-Word file created with MS-Office 2003 or below by online submission to [www.psam9.org](http://www.psam9.org) no later than 22 February 2008. It is important that the papers are formatted in accordance with the instructions herein to avoid delay on the electronic publishing. Papers should not exceed 8 A4-size pages, including references and appendices.

Because the Conference Proceedings will be in electronic CD-ROM to avoid format shifting during preparation, color versions are encouraged in all pictures and graphics and these should be included at the proper location of the paper. The Conference Organizer will not be responsible for shifting of tables and graphics in the final publication.

It is important that the authors use their own technical editor and go through the paper to ensure the proper production quality.

## 2. FORMATTING AND UNITS

The text of the whole paper should be in 11 points, Times New Roman. Please do not use any special fonts or foreign text characters. All margins should be set to 2.5 cm (1"). There is no indention of the beginning of a paragraph. The alignment of the paragraphs should be set at "justified" and separated by one blank line. All text should be set for single line spacing. Please do not use the double column format in the preparation of the full paper. Page numbering is not required.

## 3. ADDITIONAL REQUIREMENTS

### 3.1. Author Information

If there is more than one author, please put a, b, c, etc. in superscript after the name of each author, as indicated in the example above. If the authors have the same organization, city and country, please use one common letter and list the information once to identify them. Please do not put and the job title of the authors. Please put an asterisk (\*) after the name of the contact author, whose email address should be placed in the footnote on the first page.

### 3.2. Headings, Tables, and Graphics

First level heading should be in bold, uppercase; second level headings in bold, title case; third level should be in regular title case, and underlined.

Text in tables should be at least Times New Roman 10 pt. Tables, pictures and graphs have to be centered, numbered and must have titles. Numbers and titles of tables, pictures and graphs have to be above tables or pictures, and have to be centered. The example of how to format a table is Table 1 below.

All pictures and graphics are in color or in black and white.

Formulas have to be centered, and at the right margin they can have numbers in parentheses, like in the next example:

$$T_n = T_{n-1} + 2n - 1 \quad (1)$$

### **3.3. References**

All references cited in the paper should be numbered in square brackets such as [1] and [2,3]. The references should be listed at the end of the paper in the Reference Section. Please do not include references that are not cited in the paper.

## **4. CONCLUSION**

All paper should have a concluding remark to highlight the findings.

### **Acknowledgements**

The acknowledgements for funding organizations etc. should be placed in a separate section at the end of the text. Thank you for your cooperation in complying with these instructions.
